You have availed loan from Indian Bank, Faridabad Old branch, the repayment of which is secured by Mortgage of schedule mentioned property hereinafter referred to as "the Property". All of you failed to pay the outstanding dues to the Bank. As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
