Sub: Loan account – M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd (A/c No- 6398274930/ 6887986623) with Indian Bank, Borivali West Branch.

M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd availed MSME loan facility from Indian Bank, Borivali West Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 17/05/2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd liable to the Bank to pay the amount due to the tune of Rs. 94,78,360.00 (Rupees Ninety Four lac Seventy Eight thousand Three hundred and Sixty Only) as on 01/03/2022 with further interest, costs, other charges and expenses thereon. They failed to make payment despite Demand Notice dated 17/05/2022.

As M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd failed to make payment despt Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18/08/2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on Rs. 94,78,360.00 (Rupees Ninety Four lac Seventy Eight thousand Three hundred and Sixty Only) with further interest, costs, other charges and expenses thereon from 01/03/2022.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 26th June 2023 which would be by e-auction mode.
