- Date and time of Auction: **26.12.2024 from 11:00 AM to 05:00 PM** with unlimited Auto-Extensions of 05 Minutes Each.
- Property can be inspected on **23.12.2024 between 11.00 A.M. to 04.00 P.M.** with prior Appointment from respective Authorised Officer.
- E-Auction would commence on the Reserve Price plus first incremental value as mentioned above. Bidders shall improve their offers in multiples mentioned in the above table for all the properties simultaneously.
