3 more arrested in Patna hospital murder case

ARA, July 22 (PTI)

THREE persons, wanted in the murder of gangster Chandan Mishra at a hospital in Patna, were arrested in Bihar's Bhojpur district on Tuesday following a gun-fight with the police, officials said. Those arrested were identified as Balwant Kumar, Raviranjn Kumar Singh and Abhisekh Kumar.

Acting on a tip-off, a joint team of the Special Task Force and district police around 5 am reached the Bihiyan area where they were hiding. Noticing the police personnel, they tried to escape by opening fire, officials said. The security personnel retaliated and overpowered them. Balwant Kumar and Raviranjn Kumar Singh sustained bullet injuries. No policemen were injured in the exchange of fire, officials said. Three pistols and two magazines with four cartridges were seized from their possession, they said. Kumar and Singh are undergoing treatment at a Government hospital in Ara, the district headquarters of Bhojpur.

Mishra, a murder convict who was out on parole, was shot dead by gunmen inside a private hospital in Patna on July 17. Police arrested Tauseef alias Badshah, the prime accused, his cousin Nishu Khan and their two associates, Harsh and Bhim, from Kolkata on Saturday in connection with the case.

IN A significant development, the Supreme Court on Tuesday sought responses of the Centre and all States on the presidential reference raising constitutional issues on whether timelines could be imposed for dealing with bills passed by Assembly.

Observing that the issues raised in the Presidential reference will affect “the entire country”, a five-judge Constitution bench headed by Chief Justice of India BR Gavai sought the replies in a week and fixed the reference for fixing timelines and other procedural details on July 29.

“There are issues of interpretation of the Constitution. We have requested the Attorney General to assist us. Issue notice to the Union and all State Governments. The Solicitor General will appear for the Union. All State Governments be served through emails. List it on next Tuesday. Notice be also served to all standing counsel,” ordered the bench which also comprised justices Surya Kant, Vikram Nath, PS Narasimha and AS Chandurkar.

During a brief hearing, Senior Advocates KK Venugopal and P Wilson, representing Kerala and Tamil Nadu respectively, opposed the reference and questioned its maintainability.

These objections can be raised later, the CJI said, adding the matter will be taken up in mid-August.

In May, President Droupadi Murmu exercised powers under Article 143(1) to know from the top court whether timelines could be imposed by judicial orders for exercise of discretion by the President while dealing with the bills passed by State Assemblies.

Article 143 (1) of the Constitution deals with the power of President to consult the Supreme Court “if at any time it appears to the President that a

question of law or fact has arisen, or is likely to arise, which is of such nature and of such public importance that it is expedient to obtain the opinion of the Supreme Court upon it, he may refer the question to that Court for consideration and the Court

with bills questioned by the Tamil Nadu Government.

The verdict for the first time prescribed that the President should decide on the bills reserved for her consideration by the Governor within three months from the date on which such reference is received.

In a five-page reference, President Murmu posed 14 questions to the Supreme Court and sought to know its opinion on powers of Governor, President under Article 200 and 201 in dealing with bills passed by the State legislature.

Article 200 deals with situa-



tions with regard to passage of bills by the State assembly and subsequent options available to the governor on grant of assent, or withholding of assent or sending the bill to the President for reconsideration.

Article 201 deals with the bills reserved for the President's consideration by the Governor.

The rules prescribe for the review petitions to be heard by the same set of judges in the apex court in chambers while Presidential references are heard and considered by a five-judge Constitution bench.

Article 200, the reference underlined, which prescribes powers of Governor to be followed while assenting to bills, withholding assent to bills and reserving a bill for President's consideration, does not stipulate any time frame upon Governor for the exercise of constitutional options.

President Murmu said similarly Article 201, which prescribes the powers of President and the procedure to be followed while assenting to bills or withholding assent, therefrom does not stipulate any time frame or procedure to be followed by the President for the exercise of constitutional options under Article 201 of the Constitution.

President Murmu also questioned the exercise of plenary power under Article 142 of the Constitution by the Supreme Court to make the bill re-presented to Tamil Nadu Governor, as deemed to have been passed.

'I don't know how to play online rummy; will sue Oppn leaders who defamed me'

MAHARASHTRA Agriculture Minister Manikrao Kokate said he will take legal action against the Opposition leaders who “defamed” him by sharing a video claiming he was playing a game of ‘rummy’ on his mobile phone.

Talking to reporters, NCP leader Kokate asserted he does not even know how to play online ‘rummy’ and said he will write to Chief Minister Devendra Fadnavis and Legislative Council Chairperson Ram Shinde to investigate the video.

A political storm erupted on Sunday after NCP (SP) MLA Rohit Pawar posted on his X handle a video clip of

Kokate sitting in the Legislative Council.

On Monday, NCP (SP) MLA Jitendra Awhad posted two videos, claiming Kokate was playing ‘Jungle rummy’ on his mobile phone during the recent Monsoon Session of the State legislature. Amid the growing clamour for Kokate’s resignation, NCP State President Sunil Tatkar on Monday said the party head and Deputy CM Ajit Pawar will take a serious note of the video and talk to the Minister accordingly. Facing flak, the Minister on Sunday said he was only trying to skip the downloaded rummy game on his mobile phone in the Legislative Council.

Hundreds throng to pay homage to Achuthanandan



THIRUVANANTHAPURAM, July 22 (PTI)

HUNDREDS of people waited outside the historic Darbar Hall here to pay homage to former Chief Minister and veteran CPI(M) leader V S Achuthanandan on Tuesday, a day after he breathed his last at the age of 101.

The mortal remains of the veteran were taken in a procession from his son's residence in the morning to the Hall inside the Secretariat for official public homage. A large number of party workers accompanied the ambulance. Several others followed in their vehicles.

Thousands of people, including women, the elderly, and students, paid their last respects to Achuthanandan when his body was kept at the old AKG Centre on Monday night. By around 11.45 pm, the body was shifted to his son's residence in the city and kept there till the morning.
