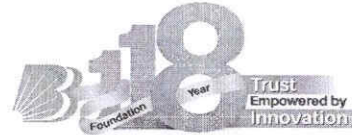

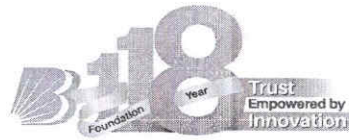

8. 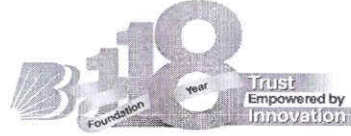
