Rahul to launch campaign to rebuild party's s

LUCKNOW: Rahul Gandhi, the Leader of Opposition in the Lok Sabha, will launch a Dalit outreach initiative for the Congress in Uttar Pradesh on Friday on 'Samajik Parivartan Diwas' to rebuild the party's social base ahead of the 2027 Uttar Pradesh assembly elections.

The move comes two days before the birth anniversary of Kanshi Ram, the Dalit ideologue and Bahujan Samaj Party founder whose political legacy continues to shape Dalit politics in the state. This will be Rahul's first public event in Lucknow after a gap of nearly two years. He addressed the 'Samvidhan Bachao Sammelan' in May 2024, during the Lok Sabha election on the same Indira Gandhi Pratishthan campus.

Friday's programme will bring together Dalit leaders, social activists and intellectuals. It will focus on social justice and political empowerment.

By putting Kanshi Ram's ideas of Bahujan empowerment in the foreground, the Congress hopes to reconnect with the community that once formed a crucial part of the party's support base.

"Dalits are facing their worst time under the BJP government in Uttar Pradesh and this event will ignite the torch of social justice across the state," said Ajay

gramme, Rahul Gandhi is expected to emphasise issues such as caste census, social justice and enhanced representation for marginalised communities.
