

Discussions under way to identify land for AIIMS in Kovai: Min Arunraj

Health min reviews medical infra projects in Kovai, T'pur; allays fears of Shigella spread in TN

Discussions are under way to establish an AIIMS in Coimbatore, and an announcement in this regard would be made soon, said Minister for Health and Family Welfare KG Arunraj on Saturday. Arunraj inspected government healthcare facilities in Coimbatore and Tiruppur, reviewed medical infrastructure projects and addressed a range of issues, including on the proposed AIIMS hospital in Coimbatore, NEET-related student stress and the state's healthcare priorities.

In Coimbatore, Arunraj visited the Employees' State Insurance (ESI) Hospital and the Coimbatore Medical College Hospital (CMCH), where he participated in a graduation ceremony and distributed degrees to beneficiaries. Later speaking to reporters, Arunraj revealed that discussions were under way to identify a suitable site for establishing an AIIMS in Coimbatore. He said the proposal had been taken up with the Union government after Chief

Minister C Joseph Vijay raised the issue during a meeting with Prime Minister Narendra Modi. "We have discussed possible locations with the district collector," he said.

Referring to the Madurai AIIMS project, the minister noted that work had finally commenced after years of delay and was progressing steadily. Addressing concerns over recent student suicides linked to NEET, Arunraj described the deaths as deeply tragic. While reiterating his party's opposition to NEET, he urged students not to take extreme decisions. The minister encouraged stu-

dents and families to utilise the state's mental health support services through the 104 helpline and the "MANAM" counselling initiative. "Medicine is only one course of study. Not securing a medical seat does not mean life has come to an end," he said, extending his best wishes to candidates appearing for the examination.

Earlier in the day, Arunraj conducted a surprise inspection at Tiruppur Government Medical College Hospital. He also inspected the under-construction cancer treatment centre. Officials informed him that the project is expected to be

completed by September next year. The minister also announced steps to procure an advanced 3D simulator for the cancer centre. Responding to local demands, he said the government would examine the possibility of creating a dedicated neurosurgeon post in Tiruppur to provide emergency treatment for head injury cases. On public health concerns, Arunraj clarified that no Shigella infections had been reported in Tamil Nadu so far. During the Tiruppur visit, attendants of patients at the hospital raised concerns about the lack of access to hot drinking water and the minister assured that appropriate measures would be taken to address the issue.

When reporters questioned when the Magalir Urimai Thogai would be disbursed to everyone and when the women could expect to get it, Arunraj remained silent for a moment before leaving after implicitly stating, "The state's financial situation is currently not sound. It can only be disbursed after the situation is gradually rectified."

RTI reply on quarry records dissatisfactory: Farmer leader

FARMER leader P Kandasamy, also the general secretary of a farmers' association, expressed dissatisfaction with the response provided by the Public Information Officer (PIO) and Deputy Director of Geology and Mining, Coimbatore, regarding information sought under the RTI Act about quarry operations in the district.

In the RTI reply, the PIO stated that quarry records were not maintained in a compiled format and that collecting, compiling, and providing copies of all quarry files would disrupt regular office work.

The officer noted that the requested records would amount to nearly 10,000 pages and added

that the RTI Act does not require authorities to compile information in a new format. However, specific information would be provided if requested separately.

Kandasamy, who sought the records to examine alleged irregularities in quarry operations, was further disappointed when officials declined his request to inspect the files in person. The PIO explained that the office lacked sufficient staff, including a record clerk and junior assistant, to supervise the inspection and safely maintain the records, leading to the denial of permission. Kandasamy alleged that the PIO has been giving identical responses to multiple RTI applications filed by him regarding quarry operations.

Action plan to curb learning gap among schoolchildren

OFFICIALS from the school education department have made a decision to launch an action plan in July to address learning gaps and improve learning outcomes among primary and middle school students, following the poor performance of the district in the State Level Achievement Survey (SLAS) last year.

An educational officer told *TNIE* that under the initiative, students from classes 3 to 8 would be categorised into four academic levels — A (excellent), B (good), C (average) and D (poor). He said teachers would tailor their methods, with greater focus on academics for students in C and D levels. "Headmasters will assess the students twice a week. In addition, block resource teacher educators (BRTEs) and block educational officers (BEOs) will review the assessment reports and evaluate students."

Chief Educational Officer R Balamurali told *TNIE* that learning outcomes would be continuously assessed.
