M/s Betterworld Futureworks Proprietor Mr. Jayesh Wadhwani availed MSME OCC Limit facility from Indian Bank, Bengali Chouraha Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Betterworld Futureworks Proprietor Mr. Jayesh Wadhwani failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), M/s Betterworld Futureworks Proprietor Mr. Jayesh Wadhwani, liable to the Bank to pay the amount due to the tune of **Rs. 24,69,342.49/- (Rupees Twenty four lakh sixty nine thousand three hundred forty two and forty nine paise only)** as on 17.04.2026 with further interest, costs, other charges and expenses thereon. Borrower failed to make payment despite Demand Notice dated 18.04.2026

As M/s Betterworld Futureworks Proprietor Mr. Jayesh Wadhwani failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the

same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **20.07.2026** is **Rs. 26,09,188/- (Rupees Twenty six lakh nine thousand one hundred eighty eight Only)** with further interest, costs, other charges and expenses thereon from **21.07.2026**

The date of sale is fixed as 27.08.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id.
